### Pipeline plan

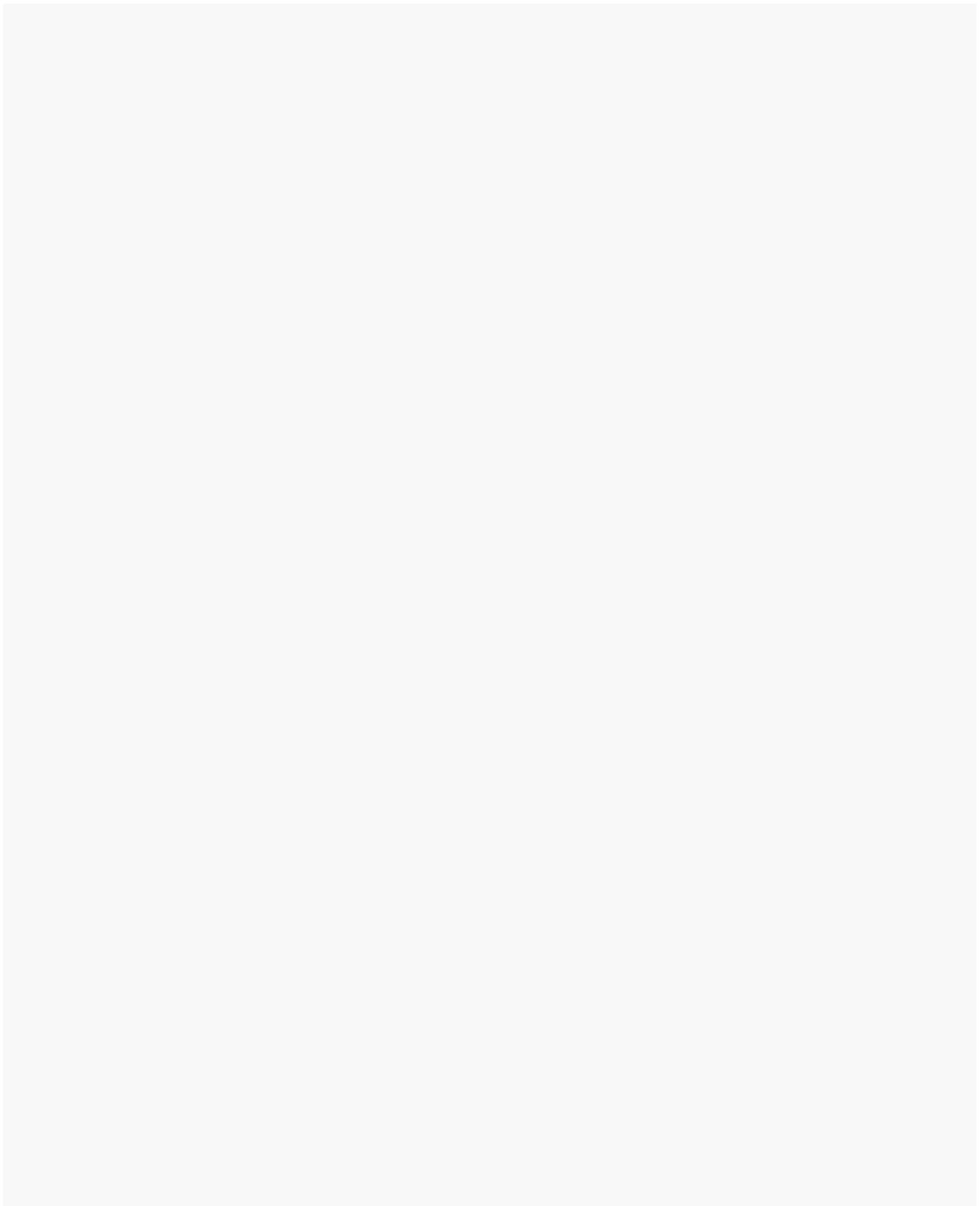

During his time at W Hotels & Resorts, Mr. Azarbarzin worked directly with Mr. Sternlicht, before the hotel chain was sold to Marriott International.

Aside from day-to-day operations at SH Group, Mr. Azarbarzin will spearhead 1 Hotels openings in Los Angeles ([see story](#)), Cabo, Mexico; Sunnyvale, CA; Sanya, China and Paris. In addition, Mr. Azarbarzin will direct global initiatives to further the 1 Hotels' 1 Vision hospitality concept to transform the industry and society.

As for Baracart Hotels & Resorts, branded with the French crystal maker, an expansion plan for the hotel will soon be announced.
